Contracted Undertaker services made up of the following:

- Provision of storage
- Coffin
- Transportation of the body
- Family car
- Registration of death
- In the case where the body has been taken to a non-contracted service provider to remove and cover the storage costs (*limited to 3 days*)

Burial sites and times

- Burial sites are limited to the nearest affordable one to the family place of residence as determined by City Parks.
- Cremation option available to families
- No burial is provided beyond the geographical borders of the City of Johannesburg
- Burials are conducted only during the week from Monday to Friday
- Burials conducted within 72 hours from the time of death or notification to the Ward Councillor and city officials

Declaration

- Applicants are required to complete a Declaration Form that the deceased person has not been covered through funeral insurance policy by any member of the family or relative.
- Applicant required to make an undertaking to report to Council should it be later discovered that the deceased had an insurance cover so that the costs to bury can be recovered from the policy holder.

Social Burial Policy



Social Burial Policy



The Social Burial Policy seeks to provide indigent families with a dignified burial and minimise the need for paupers' burials in the cases where the next of kin are known. The burial is provided within reasonable and available means.

Prior to the introduction of this policy the option available to the poor was the paupers' burial . The limitation of the pauper burial scheme is that it is available to people that are in the government mortuary. In the event that the person dies outside of the hospitals the burden lies with the families and unfortunately even though the families do not have the means of burying their loved ones they are forced to move them into a private mortuary. The costs of burial inevitably increases and become even more unaffordable due to escalating storage fees while the family tries to secure funding for the burial.

Registration on ESP

All the reported bereaved indigent families to be registered on the Expanded Social Package if not already registered

Eligibility

Only South Africans living within the boundaries of the City of Johannesburg with a vaild South African Identity Document are eligible



Notification Process

First Step: The bereaved family or concerned

member of the community notifies

the Ward Councillor

Second Step: Ward Councillor provides a referral

letter to the Regional Social Development Department

Third Step: Social worker undertakes the

assessment of the family and makes

recommendation

Fourth Step: Qualifying applications are



Roles of Social Development Department and City Parks

Social Development Department

- Social workers assessment forms, and councillor's recommendation submitted to the relevant office in City Parks within 24 hours of receiving the notification.
- Liaise with the relevant parties which will include the family, City Parks officials and undertaker to ensure that the burial is concluded within the set 72 hours
- Compile a closure report on each of the indigent burials and quarterly report for the Section 79
 Committee
- Follow up on all fraudulent applications where people in avoiding to take responsibility for burial of their family member claimed poverty and failed to disclose that the person was covered through a funeral insurance policy or burial society. In such instances a case to be opened at a local police station as a deterrent.



City Parks

- Social Development Department has contracted City Parks to facilitate the burial process
- Social burials are provided through contracted undertakers hired by City Parks.

¹ The definition of a pauper as contained in the City of Johannesburg Cemetery by-laws provide as follows: "Pauper means a person who has died as an unknown person or if no relative or other person can be found to pay for the burial or cremation cost of the deceased person" This definition in no ways implies that the Council takes responsibility but is only to be read within the context of the by-laws and provisions of the said Inquests Act, 1959 and the said Births, Marriages and Deaths Registration Act, 1992. A pauper is buried in a Cemetery as determined by Council, three/four in a grave and without a headstone.
